Request for Bids for Self Contained Breathing Apparatus and Rotary Vent Saw

#### Overview

The Peacham Volunteer Fire Department is requesting bids for the purchase of Self Contained Breathing Apparatus to replace our current equipment. This will include all hardware, software, services, equipment, installation and training (as detailed herein) to provide for complete sets of equipment.

Also included in this package is a rotary vent rescue saw.

With a purchase of this dollar value the Peacham Volunteer Fire Department requires a formal bid process. Bids submitted under this solicitation shall be binding and valid for a period of 90 days from the date of submission. All bids must be submitted in a sealed envelope with "Self Contained Breathing Apparatus" clearly printed on the outside. Envelopes should be addressed to:

Any questions or further information needed can be requested via email to msimakaski@gmail.com. Vendors are encouraged to offer suggestions for improvement beyond the equipment identified as long as they are to the benefit of the Peacham Volunteer Fire Department and clearly identified price differences are included. All formal inquiries should be written (electronically or mechanically) and responses will be provided in same manner.

Vendor may use any format to provide the bid as long as the bid is typewritten, professional, clearly delineated and easy to follow for the average reader.

The deadline for bids to be submitted will be Friday, 15 December 2023 by 3pm (EST). Bids may be delivered by hand or by mail but must be present at the deadline. Postmark date is not acceptable.

Within two business days of the posted deadline the bids shall be opened by the Fire Chief or his designee during a Grant Committee meeting. Bids shall be reviewed for acceptance, and upon approval by the Grant Committee, the successful vendor shall be notified to initiate the purchase.

The Self Contained Breathing Apparatus (SCBA) to be provided in response to this solicitation shall be MSA G1 EXTREME.

# SCBA shall meet the following minimum requirements:

System Pressure: 4500 PSIG

• Cylinder Connection: CGA threaded remote connection

Harness: Standard with chest strap

Cradle Type: Metal band

· Lumbar Type: Adjustable (up and down) and swiveling lumbar pad

• Regulator Type: Vendor to advise

• Regulator Hose Type: Continuous

• Emergency Breathing Support: The department requires connections suitable for emergency RIT filling.

Speaker Module: Left chest

• PASS: Right shoulder / Right shoulder with TIC (see quantities below)

• Battery Type: Rechargeable

• RIT packs with 60 minute bottles and hoses and accessories as needed.

## **Professional and Managed Services Requirements**

Professional services shall be provided by the vendor and shall include:

- A primary point of contact residing within 90 miles of Peacham, Vermont.
- Equipment Inspection / Place Into Service Installation and programming of all electronics, modification of standard programming if required,
- Equipment Testing Testing of equipment post installation as part of commissioning and overall final functional acceptance testing.

In responding to this RFP the vendor shall include all hardware, software, installation and configuration services and expenses, and costs broken out separately. While all of the SCBA and other equipment are to be included in the total price for the system, the line item costs for all components and services (i.e. installation, configuration) shall be included as an attachment. In all cases, the vendor must list manufacturer part numbers on the bid documents. Failure to include part numbers or line item costs will result in delay of bid award and possible rejection of bid.

The Peacham Volunteer Fire Department has attempted to provide information that may be of benefit in formulating the vendor's proposal, but it is the responsibility of the vendor to ensure their proposal is accurate, complete and capable of providing a complete and functional suite of SCBA equipment.

Bidder shall warrant all equipment to be free from defects in material and workmanship, and to operate in accordance with these specifications for a period of not less than fifteen (15) years from date of installation for the SCBA and two (2) years for the rescue saw.

Products manufactured and assembled in the United States shall receive preferential consideration.

#### **Response Format**

The Peacham Volunteer Fire Department requires each vendor's proposal to include the following sections:

- Executive Summary Description of the overall equipment proposed including any items that are different from the specific radios and equipment being solicited in this RFP.
- Warranty and Maintenance This section should include a description of equipment warranties that come with a purchase as well as applicable time periods that the equipment is covered under warranty.
- Vendor Qualifications This section should include a detailed description of the vendor, the physical address of the vendor location, the number of years the vendor has been in business, and a website address.
- Bid Forms Each vendor should submit a detailed parts list with quantity, the manufacturer part number, and a description of the part with the cost for same as previously described.
- Payment Terms This should include a description of the vendor's standard payment terms for a project of this type. The Peacham Volunteer Fire Department reserves the right to negotiate payment terms upon contract award but generally will not issue payment for the project before all of the equipment is received and functioning properly.
- Optional Information This section should include any additional information pertaining to the bidder's response that was not specifically addressed in any other section.

The following is the criteria which will be utilized to weigh the lowest responsive and

#### responsible bidder:

- 1. Vendor Qualifications
- 2. Quality and Completeness of Proposal Submitted
- 3. Compliance with Specification Requirements
- 4. Warranty, Services and Maintenance Requirements
- 5. Pricing of Components

The Peacham Volunteer Fire Department reserves the right to disqualify any non-compliant vendors and solutions and reserves the right to reject any and all proposals submitted.

### **Project Award**

It is the intent of the Peacham Volunteer Fire Department to award this project to a single qualified vendor who can provide all of the required equipment. The Peacham Volunteer Fire Department reserves the right to waive informalities and irregularities, reject any and all bids and make no award in response to this RFP in the best interest of the Department.

If an award is made as a result of this RFP, it shall be awarded to the respondent whose proposal is most advantageous to the Peacham Volunteer Fire Department with price and other factors considered.
