Minutes of the Peacham Energy Committee – 21 January, 2026

Summary

The meeting began with technical difficulties being resolved for a Zoom meeting link, followed by an update on Bevin Barber-Campbell's grant application for E-Bike lending (passed!), and then discussions about yesterday's Peacham Planning Commission meeting that discussed 2 upcoming grants for assistance with climate resilience planning.

The group explored various town planning initiatives, including potential community solar projects and volunteer programs, while discussing the importance of updating the town plan and engaging with the Planning Commission. The conversation ended with plans to present community energy assistance programs at an upcoming town meeting and discussions about expanding window dressing services to new areas, along with a decision to move future meetings to 7pm Eastern Time on the second Wednesday of each month.

Committee Priorities

- Complete the rollout of the volunteer energy assistance program
- Make sure WindowDressers has the ongoing support it needs
- Seek opportunities to advance electrification in Peacham, such as a second community solar array/battery system
- Explore collaboration with other groups, including the Planning Commission and Emergency Management in Peacham, and other Energy Committees in the NEK
